FEATURES

DALTON COATINGS SS-1 Tack Coat is an anionic asphalt emulsion designed for use as an adhesion promoter for patching, paving, overlays and coating blacktop. SS-1h promotes adhesion to blacktop (bituminous concrete). It can be applied via spray, brush or squeegee and dilution is not necessary. Most all sprayers will work. There is no aggregate in the material. The material will not clean up with water so a solvent will need to be used. Therefore, the sprayer system must be able to withstand solvents to clean up.

CRACK-STIX® is a low VOC product. Meets specification as per ASTM D 977 and AASHTO M140

COVERAGE

Coverage per gallon is approximately 100 sq.ft/gallon

SURFACE PREPARATION

Work area must be clean and dry to ensure a proper bond. Before applying the product, it is important to thoroughly clean the area using a sturdy broom to remove foreign materials and loose debris. If possible, surface can be cleaned. It is recommended to re-sweep the area immediately before application.

APPLICATION

Apply coating on clear day only when air temperature is 55° F and rising and rain is not likely. Apply using spray, brush, or squeegee. Stirring may be needed to obtain a uniform mix. If possible, it is recommended to flip over the pail at least 24 hours prior to using the product. (Carefully inspect the lid to insure it is secure before turning over).

If spraying, ensure nozzles are appropriately sized for the application and thoroughly cleaned before use. Adjustment of sprayer height and pressure will affect pavement coverage. Surface condition will also affect coverage, increased surface texture will require more tack.

PRECAUTIONS

Avoid applying coating during rain and when temperatures drop below 55° F. When transporting this product, ensure that the container is secured and the lid is secure. Do not allow the container to tumble as this may loosen the lid and allow leakage to occur. Do not transport on passenger seats or inside the passenger compartment of any vehicle. Protective clothing and eyewear should be used during application.

CLEAN UP & STORAGE

While wet, clean up with soap and water. If dry, scrub with citrus based cleaner or mineral spirits. Containers are recyclable. Do not heat or store container in temperatures below 50° F or above 110° F. KEEP FROM FREEZING! Product is Non-Hazardous.
